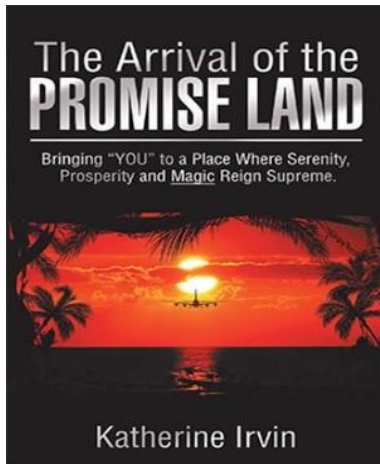

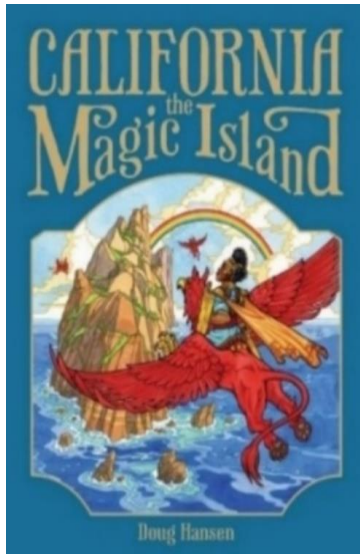

KATHERINE IRVIN. April 3rd, 2023. War was brought my door after I submitted my Emergency Housing Proposal to end homelessness starting in California State. Into the Chino City Mayor Online Bidding Portal. Between 6/6/ and 3/17 of 2023. War was then brought to my door and Verbal Confrontations broke out between me and the evil SB-SWAT Team Sheriff Department that I call. "Mr. Portley Fat Pudgy" SB County-Sheriff Police places WRIT Eviction Notice to Vacate on Katherine Door. On April 3rd, 2023.

SB SHEIRFF POLICE "Between now on April 3rd and April 10th. I'm going to remove You from this apartment. Placing A WRIT Eviction Notice to Vacate on Door".

KATHERINE: For what? For submitting a proposal to end homelessness? Why are you here? What is a WRIT? Boy "Mr. Portley Fat Pudgy" you people are real Parasites that sincerely needs to be removed from office or worse.

Katherine calling the SB-Sheriff "Mr. Portley Fat Pudgy". Not because of his body weight but because of him and the entire city-police department being FAT from the Misery and Blood of the Saints. From the blood of the Indigenous people being invaded by the City Mayor Police. Makes the entire U.S. Government tremendously Parasitic and Fat".

My verbal rage increased sending the Sheriff running down the stairs literally shitting his pants in front of me. He fled and tripped on the 3rd step twisting his ankle. Because he thought the slam of my door was the sound of a gunshot. Stated by the Attorneys.] And yet, I had no weapons on me, nor did I appear to be any physical threat. Somehow caused him to bring the entire SB Swat Sheriff Police to stalk, intimidate and threaten me.

On April 7th, 2023. Suddenly a group of wild looking teenagers ages 13 to 19- years old came from the side where the Sheriff and uncover Police resides at. The groups of teens were strangely drawn to my apartment building area only. They come to "Play" with your children. The tenant's downstairs became concern of Random teenagers. They asked "Where do you guys live? The teens ran away laughing. I did not allow my son who suffers from Autism to go outside after that.

April 11th, 2023. I made YouTube Videos for everyone to be aware of the SB- Police Sheriff disguising. Themselves as the Apartment maintenance and Sanitization. Around 11:00 Am they were looking up at my 3rd story Apartment window. While asking the real Apt maintenance on how to get up to my apartment. Cause witnesses from YouTube to get involved sending Emails and calling the SB-Sheriff Police. To respect what is written in the Housing Proposal.

May 22nd, 2023. My electricity was turned off around 11:40 am. At 12:00 noon time. The Swat Team Sheriff was at my door with Shields up and High-Powered Weapons Pointed at me, my son, and my grandbaby Isis. Telling me they need to place hand cuffs me.

KATHERINE IRVIN why you are all here? What do you want? Is it because of that Old Hag City Mayor?

SB SWAT TEAM: We do not know we just need to place handcuffs on you” They slammed my son to the ground; My grandbaby Isis screams in horror. I was then handcuffed and walked downstair by one of the Swat holding shield. As if I was a criminal in my own apartment.

The SB-SWAT Team led me to his Police car where the land that I bided for right Infront of my residents. As I was telling the one African American Swat Policeman. Another one comes from behind me and speaks. “No. She belongs to me. She goes in my car, she’s the one who cussed me out on that day.

KATHERINE IRVIN, I turned around and said “Is that you Portley Fat Pudgy? It is you, fat pudgy. You want some more of me Mr. fatty? Don’t worry by you being such a Parasite. You’ll just expose yourself for being a criminal on land that is not yours. While you drive me to jail for nothing Mr. Fatty.” The Portley Fat Pudgy Sheriff read me my rights. Then asked me if I understood those rights.



KATHERINE IRVIN, [So enraged I can only smile saying] No Fat Pudgy I don’t understand You. And I’ll be out less than 5-days. Now go over to the Police ladies so they can check my body for weapons. Hurry. Run along now. Mr. Fatty.

A Policewoman checked my body for weapons and pulled out an Item from my chest. Mr. Fat Pudgy asked me what I needed it for. I told him, I am a single grandmother surrounded by the most dangerous and corrupt government agents in the world. I must protect myself from racist kidnappers like yourself. If, you did not drive me to jail? And took me to some random place to kill me? You would’ve found out the hard way what I needed my own weapon for. Mr. Portley Fat Pudgy!

Four days later I was released from the San Bernardino women’s correctional jail facility. On May 27, 2023, I, sat down on my daughter’s couch and saw on TV. News Channel 7 exposing the same SB- Sheriff department of their excessive Police Brutality Policies. Because my YouTube followers were sending my YouTube Video’s to them prior to the attack. Showing how the U.S. City depts discriminates against Indigenous people like me who submit. Housing Proposal into their online Bidding Portal. I was released because the court appointed attorney said that they were never supposed to break into my apartment to arrest me in the first place. Thank you for writing to share your concerns regarding the affordable housing and homelessness crisis. I appreciate hearing from you.

I strongly believe that everyone deserves a safe, stable, and affordable place to call home. The United States has a shortage of 7.3 million affordable homes available to low-income renters, and more than 170,000 people experience homelessness in California each night. Addressing the affordable housing and homelessness crisis has been one of my top priorities as your Senator.

That is why I was proud to introduce the “Housing for All Act” (S. 2701), a comprehensive bill to ensure every American has the dignity and security of housing. This bill would invest billions of dollars in proven programs that help alleviate the affordable housing shortage, including the National Housing Trust Fund, the HOME Investment Partnerships program, the Section 202 Supportive Housing for the Elderly program, and the Section 811 Supportive Housing for People with Disabilities. It would target the homelessness crisis by providing significant funding for Housing Choice Vouchers, Project-Based Rental Assistance, the Emergency Solutions Grant program, and Continuums of Care. This bill would also support innovative, locally developed approaches, such as investments in hotel and motel conversions and safe parking programs. This bill is currently awaiting consideration by the Senate Committee on Banking, Housing, and Urban Affairs, of which I am not a member.

You may also be interested to know I joined the late **Senator Dianne Feinstein (D-CA)** in introducing the “Affordable Housing Redevelopment Act” (S. 580), which would have authorized \$1.5 billion to help create new affordable housing through the rehabilitation or redevelopment of old, vacant, or foreclosed properties. This bill did not pass the Senate in the 117th Congress and has yet to be reintroduced this Congress. Furthermore, I proudly voted for the *American Rescue Plan Act of 2021* (Public Law 117-2), which was signed into law by President Biden on March 11, 2021. This law provided California with an additional \$250 million in federal funding for the Emergency Housing Vouchers program, which is made available to public housing agencies to assist those who are experiencing homelessness, those at risk of homelessness, and those who have recently become homeless. Supporting policies that allow all Americans to attain stable housing is critical. Please know that I will continue working to ensure that all Americans have access to affordable housing.

Then they must be removed from the building they are illegally occupying. Because my great grandparents were removed by them. From their homeland in Chicago Ill, to Tulsa Oklahoma to Los Angeles California. Throughout America and NOT Africa! But right here in America. Over 640 Acres was rendered to each Negro Adult like me. Stated on the U.S. Treaty Act of 1830-1902 U.S. Dawes Rolls. We cannot continue to pay for housing, Bills, Energy, Food and Water on our own land.

You and I, and everyone must ask the question of "Who is "Congress or Any, City, County, State Senator Board" to deny me or You of Funding or Housing Rights? Where did you people come from? Is Congress, and the City Mayor Indigenous to this land? Yes, or No? Where did their Great, Great Grandparents come from Alex? If, they're Families Bloodline are not Indigenous to California State or any other State throughout America? Then that person does not have the authority to dictate or deny any vote or proposal that is sent to their office. I highly encourage You to send this email to Congress or any Senate board you chose! Due, to over 640 Acres being inherited to me of my great grandparents. That can be condense down to simple permanent housing opportunities as you and I have mentioned. On my Emergency Housing Proposal Bill attachment, it needs to be approved.

We must stop beating around the bush of who land this is, all city mayor, governor to the senate is in possession of the same 1830 Treaty Indian Removal Act, Land Deed Inherited information on as me. I submitted that information to HUD-FHA & **Dianne Feinstein in 2008-2019** both refused to assist me with funding for housing development. 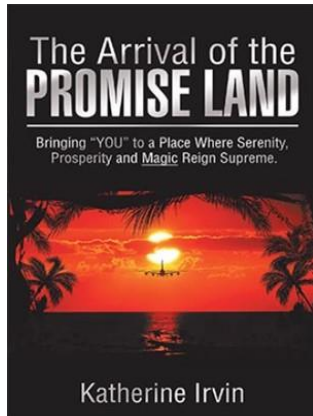
